### Session Description/Objectives:

With support from UNEP, the CEO Water Mandate Secretariat will publish in mid-April 2010 a stocktaking exercise that maps the state-of-play with regard to water accounting methodologies and supporting tools. The purpose of this study is to elucidate commonalities and differences among emerging methods and practice, to identify gaps and challenges, and to inform where water accounting methods might benefit from harmonization and increased field testing. The goal of this UNEP-Mandate half-day dialogue is to convene interested stakeholders to discuss key issues relating to emerging practice and to identify opportunities for alignment and/or coordination.

# **CEO Water Mandate Fifth Working Conference**

New York City April 15-16, 2010

#### Workshop Context and Objectives/Outcomes

CEO Water Mandate Working Conferences are designed to shape and advance the work of the initiative's three current focus areas/workstreams: water policy engagement, corporate water disclosure, and water and human rights. Specifically, the multi-stakeholder dialogue will seek to build on prior discussions, with the specific focus/output of each workstream and planned discussions in New York City described below.

#### Water Policy Engagement (To be covered Thursday)

The Mandate has embarked on the development of a Guide that will help inform and improve companies' public policy engagements. Among other things, the comprehensive framework will define the "contours and fence lines" for responsible corporate engagement in water policy, map priority water-policy issues and recommend a series of "dos and don'ts" for successful policy engagement. The discussion in New York will center on the first full draft of the Guide (to be released in late March), with the aim of reaching consensus on key substantive elements.

#### Water and Human Rights (To be covered Thursday late afternoon and Friday morning)

The discussions in New York will focus on refining the scope and objectives of the Mandate's efforts to develop operational guidance regarding how the business sector can respect the human right to water. In particular, participants will discuss:

- How companies can effectively engage with governments and other stakeholders on issues relating to community access/human right to water, and
- The pros and cons of adopting a formal corporate policy on the human right to water.

#### Water Transparency (To be covered Friday morning)

The discussion will center on current and emerging practice with regard to corporate water disclosure, as well as how and where the Mandate's transparency efforts sit within this broader, rapidly evolving landscape. Both discussions are intended to inform the Mandate's work to:

• Develop guidance to improve and make more consistent *qualitative* water reporting, with a focus on the Mandate's "process-oriented" elements (i.e., Watershed and Supply Chain Management, Community Engagement, Collective Action, and Public Policy).



• Build methods and guidance to support companies in better understanding relevant water information to report and in a manner that more effectively reflects the sustainability context of their water-related disclosures.
